11 NOTES AND CONDITIONS RELATING TO NOMINATION AND SELECTION:

- A. A. All persons nominating for selection to a ZDSAA team must use the latest official ZDSAA Nomination Form. Nominations submitted on any alternative or outdated nomination form will not be considered.
1. The Nomination Form must be completed by the nominee, either in their own handwriting or electronically, and must be signed by the Angler, Provincial Chairman and Club Chairman or Club Senior Committee Member. The nominee consents to the completion and signing of this form by electronic means in accordance with the Electronic Communications and Transactions Act, 2002.
 2. All required signatures must be obtained by the nominee before submitting the Nomination Form. Unsigned or incomplete forms will not be considered.
 3. If no fish were caught by an angler or team, the applicable sections under sections 13, 16 and 17 must be completed with "NP" meaning "No Points".
 4. Team and individual positions must be verified against the official tournament results to ensure that no incorrect information is provided. If the nominee is unsure, "NS" meaning "Not Sure" must be entered. Tournament results are available from the Provincial Secretary.
 5. The latest available tournament results must be used when completing the qualifying tournaments in section 13. Actual results must be provided, and "NS" meaning "Not Sure" will not be accepted in this section.
 6. The latest applicable version of the Road to Protea Colours Policy must be used, particularly regarding the qualification requirements for U16, U19 and U21 anglers. Anglers must ensure that they qualify before nominating, and Provinces must confirm that the qualification requirements have been met before submitting the nomination.
 7. Selectors must also be current and must have participated in the applicable events as required by the latest Road to Protea Colours Policy.
- B. No more information may be provided than the space available on the Nomination Form allows. Additional lines must not be added.
- C. No CVs, additional memorandums or other supporting documents may be attached to the Nomination Form unless specifically requested by ZDSAA.
- D. Only fish caught during the five years preceding the closing date for nominations, strictly in accordance with IGFA Line Classes and Rules, may be included in the Nomination Form.
- E. Each nomination must be accompanied by proof of payment of a non-refundable nomination fee of R250. The nominee's name and surname must be used as the payment reference. Junior U16 and U19 nominees are exempt from paying the nomination fee. Payment must be made into the following account:

 - Proof of payment must accompany the Nomination Form in the same email.

- F. The completed Nomination Form, together with proof of payment where applicable, must be submitted to the ZDSAA Admin Office on behalf of the Convenor of the ZDSAA Selection Panel. It must be received by no later than the closing date and time stated in the official Call for Nominations.
- The Nomination Form and proof of payment must be submitted as clear and legible documents in a single email. Late, incomplete or unclear nominations will not be considered.
- G. Successful nominees will be notified of the Selection Committee's decision by the Chairman of ZDSAA as soon as reasonably possible after the selection has taken place. Under no circumstances will any further information regarding the selection process or decision be provided to any person.
- Selectors may, however, advise anglers on how they may improve their prospects of future selection if contacted by the angler concerned.
- H. If a nominee has any record fish to their credit or has placed among the top individual anglers in any tournament, the relevant details must be provided in section 9 of the Nomination Form.
- I. Each selected team member will be personally responsible for all costs and expenses arising directly or indirectly from their participation in the tournament.
- J. Captain duties and responsibilities when selected for a ZDSAA team:
1. The Captain must liaise with all team members regarding the tournament and keep them informed of all relevant arrangements and requirements.
 2. The Captain must ensure that all team members sign the Code of Conduct and any other required documentation and return the completed documents to the ZDSAA Secretary before departing for the tournament.
 3. The Captain must arrange all required accommodation, travel and foreign exchange bookings for the team. Relevant tournament information may be obtained from the ZDSAA International or Local Tournaments Officer, as applicable.
 4. The Captain must ensure that the team has the correct official ZDSAA clothing. The Captain must obtain all clothing requirements and sizes from the team members and place a single consolidated order with the recognised supplier of ZDSAA clothing.
 5. The Captain must inform all team members that no spouse, girlfriend or boyfriend may accompany the team, in accordance with the applicable SADSAA Council decision.
 6. The Captain must collect the medical information and emergency contact details of all team members before departure.
 7. The Captain must ensure that all team members comply with any tournament, travel, administrative and reporting requirements communicated by ZDSAA.
 8. After returning from the tournament, the Captain must complete and submit a Captain's Report covering the tournament, the team's final position, the performance of the individual anglers and the behaviour of the team members.
 9. The Captain's Report must be submitted to the email addresses stipulated on the applicable report form within the period specified by ZDSAA.
- K. If a nominee is unsuccessful in being selected for a ZDSAA team, the nominee must indicate whether they would be willing to participate in a Barbarian team as a ZDSAA angler by selecting the appropriate option below:

- L. All selected team members must comply with the lawful and reasonable instructions of ZDSAA, the relevant Tournament Officer, the Selection Committee and the Team Captain.

- M. After returning from the tournament, every team member must complete and submit the required Captains/ Angler's Report to the email addresses stipulated on the report form within 14 days after the tournament has concluded. Failure to submit the required Captain's Report or Angler's Report may result in future nominations to represent ZDSAA being refused.

12 I, THE UNDERSIGNED, DECLARE THAT:

- a. The particulars provided in this Nomination Form are true, complete and correct.
- b. If selected, I undertake to comply with all rules and reasonable requirements imposed by ZDSAA, the Selection Committee, the relevant Tournament Officer or the Team Captain.
- c. I indemnify ZDSAA, its office bearers, officials and representatives against any claim arising from loss, damage or injury suffered by me in connection with my participation in the tournament, except to the extent that such loss, damage or injury was caused by the gross negligence or wilful misconduct of ZDSAA or its representatives.
- d. I understand and consent that my nomination form and tournament reports may be viewed by relevant SADSAA and ZDSAA portfolio holders who are bound by confidentiality requirements.
- e. I confirm that I have read and understood the Notes and Conditions Relating to Nomination and Selection set out above, that they are binding upon me, and that I agree to comply with them.
- f. I consent to my name and photograph being published in Ski-Boat Magazine and on the official SADSAA and ZDSAA social media platforms. I understand that social media posts may be viewed and shared by members of the public.
- g. I confirm that I am able to cover all costs associated with the tournament. This includes any deposit reasonably requested by the Team Captain for organisational purposes and my pro rata share of the tournament entry fee. I undertake to make the required payment to the Team Captain within 25 days after being notified of my selection, or by any earlier payment deadline imposed by the tournament organisers.
